We should have known - identical twins aren't identical after all, The Sciences, vol. 9, No. 4, pages 7-9. "Very Dissimilar Identical Quads." "Although the genetic individuality of virtually every living organism has been widely accepted by biochemists, the idea that even genetically identical animals are uniquely different from each other is startlingly new." Williams and Storrs propose, "If, as we have postulated and as our experiments seem to support, the control of the extent of the proliferation of the various differentiated cells is centrolled by extrachromosomal factors, then these factors, which may be thought of as ' turning genes off and on', may be of the utmost importance in mammalian inheritance.

If their hypothesis is correct, only the work on single=cell organisms--the main objects of genetic study--may remain valid. How animals with highly differentiated cells pass on inherited traits becomes again a partial mystery. The

highly-prized environment heredity studies of identical twins, who may not have an identical inheritance after all, are questionable, and the expectation that genetic engineering can eliminate disease and alter development may well be premature.

Another Failure - The surel is not any better than a reading test when it comes to finding children's aptitude. It has long been noted that some children do poorly on verbal tests. There has been no way of knowing whether this was due to reading on verbal deficiency. Ronald P. Carver describes in the winter issue of College Board Review "An experiment That Failed: Designing an aural Aptitude Test for Negroes." According to the report am aural test was developed with the content beauti upon the regults of interviews with a number of youth living in disadvantaged neighborhoods in Washington, D. C. When administered to "disadvantaged" children the same difference which occurred in a reading test of verbal aptitude appeared as a result of the

"Elementary Student's Behavioral Emoblems: Teacher perception and Treatment" by Russell and May Dobson. Journal of The Student Personnel Association for Teacher Flucation, vol. #2 pages 37-12. The findings - "teacher do seem to be cognizant of desirable procedures as expressed in the literature and research for treating behavioral problems of elementary school children. They do send to alter their attitudes toward rehavioral problems if they teach in lower sociocomomic neighborhoods by becoming more cognizant of the psychological, emotional, and social development of the children they teach as compared to teacher in middle class neighborhoods. Teachers are influenced in a positive way concerning disciplinary action on theatment of behavior problems by preparation courses more than are attitudes that reflect judgement, opinion, and thought on preception of behavioral problems."

"Some in "lostions for teacherpreparation institution: College Curricul, that now exist are not necessarily effective in changing predetermined attitudes of thought and feeling about what constitutes misbehavior on the part of elementary school children."
