### Delegate Assembly Meeting

A productive, exciting meeting of the Delegate Assembly clarified some NASAP priorities. I am pleased to report two major initiatives and their implications.

NASAP will hire a professional <u>Convention</u>
<u>Coordinator</u> to assist host groups with the
complex tasks of hotels, publicity, and budgets. Lifting this burden will allow our
volunteers to devote more time to the essential tasks of a convention. The D.A. also
approved Seattle for the 1988 and Minneapolis
for the 1989 conventions.

We are continuing our efforts to make NASAP more visible in the helping professions by working with a <u>marketing</u> firm. In the next few months, you will begin to see the results of our marketing efforts. We are concerned not only with attracting new members to NASAP, but with improving services to the membership.

The Executive Committee will meet in Chicago in mid-January to continue the development of the convention and marketing initiatives.

### Social Interest Award

The Delegate Assembly has given the first NASAP Continental Social Interest Award to Jimmy and Rosalynn Carter. The Carters are acknowledged for their work with Habitat, an effort to build low cost housing in America's inner cities. We look forward to giving this award at the Fort Wayne convention.

### LETTERS

Honolulu, Hawaii--October 20, 1986

Dear Adlerian Friends:

I wish to send you my heartfelt gratitude for all the support I received from you both morally and financially over the last four years.

As most of you know, I was indicted for Medicaid fraud in March of 1983 for supposedly not having physician referrals for clients, although I turned over 100 letters to the prosecutor. Since my major work is with families, I naturally saw the children if a mother came to me and I realized that they were a part of her problems. Had I known that I needed a separate referral for each child in the family, I could have, of course, obtained one from each child's pediatrician. However, Medicaid regulations are vague and do not state how referrals should be made—written, orally, individually or by which type of medical specialist.

The case never did go to trial but there were several hearings before the Magistrate in which he recommended dismissal and the Federal Judge concurred. However, each time the prosecutor appealed. At the last hearing the Magistrate again agreed that the regulations are vague and also unconstitutionally unfair because only psychologists and not psychiatrists had to obtain physician referrals for Medicaid reimbursements.

On August 18, 1986, Federal Judge Samuel King, eight months after the Magistrate's ruling, dismissed the indictment for lack of a "speedy trial," "with prejudice," meaning that the prosecutor could not again re-indicte me with the same charges. Despite my joy over the dismissal, I still experience the high cost of this situation with Medicaid—the disintegration of my thriving psychological practice, tremendous financial loss and health problems related to the stressful factors.

I could not have gone through this ordeal without the forty plus years of Adlerian training and living which gave me the fortitude to survive without bitterness while maintaining my optimistic attitude. I am now, at age 67, experiencing my newest graduation—again building a new career of leading seminars in improving relationships as well as rebuilding my practice.

Some thirty professionals have had equally devastating situations with the Medicaid witchhunt. The entire professional community is in terror of becoming embroiled with Medicaid, therefore, very few are now taking Medicaid cases. It is sad that the poor people of this community are not getting the services they sorely need.

Again, thank you for your loving support over the many years.

### "ALFRED ADLER" EXHIBITION

The 17th International congress of Individual Psychologie is scheduled for Munster, Germany, July 12-16, 1987. On the occasion of the Congress, the German Society for IP (DGIP) plans an exhibition in commemoration of the 50th anniversary of Alfred Adler's death. A documentary is planned to show the development of IP in Germany and German speaking countries before and after World War II.

The DGIP is looking for original documents; such as, first editions of books, possibly with dedications or annotations by individual psychologists; minutes of proceedings; records for IP congresses; pictures. They welcome any suggestion that reflects the IP of the twenties and thirties, and the new beginning of IP after World War II.

#### DELEGATE ASSEMBLY MEETING

### Action Items

In addition to the items mentioned by the President in his message on the first page, the following actions were taken by the NASAP Delegate Assembly at its November meeting in Chicago.

- 1. <u>Ed Abelson</u> was elected Treasurer to fill the remainder of Tom Schramski's two year term. Tom found it necessary to resign as Treasurer but continues on the Delegate Assembly. "Abe" will be on the Executive Committee through May, 1988.
- 2. <u>Bill Nicoll</u> was elected to the Theory & Research Editorial Board of the Journal.
- 3. An item was added to the Journal Guidelines regarding the length of terms for Journal Editors and the procedure to follow in the evaluation and selection of editors.
- 4. Motion was passed that Regions be given authority to determine their own policy with regard to registration payment of presenters.
- 5. It was recommended that an exhibit package be prepared and made available for meetings being held near convention sites. The target date is for the 1988 Convention in Seattle.
- 6. A working committee was established to strengthen regional development, with Marion Balla as Chair.
- 7. A working committee was established to study the issue of a "national" certification system for trained Adlerians. Ron Pancner will chair the committee composed of Kurt Adler, Bill Nicoll, Don Dinkmeyer, Jr., Steve Maybell, Helen Cooley and Randall Thompson.

### Information Items

- 1. Membership Renewal--The Membership Committee asked Delegates to poll people in their regions who had not renewed their membership for 1986. While not all Delegates were able to complete the task, there were 39 responses. Eileen Gilchrist tallied the results. Some of the interesting results are shared here:
- a. Initial attraction to NASAP--largest number indicated "liked philosophy."
- b. Reasons for non-renewal: 16 indicated "financial" and 8 said "commitments to other organizations."
- c. Reasons for displeasure with NASAP organization: 23 said "no displeasure" and 5 indicated "too exclusionary or cliquish."
- d. Encouraging comments: "Super organization with caring members." "Pleased with the enthusiasm, organization and professional information." "Enjoyed the conferences."
- 2. Day-Care Providers—Marion Gordon-Rosen, chair of the Task Force on Training of Day-Care Providers, reports that 3-7 persons have attended her working brunches and several have contributed ideas by mail. They have compiled

materials of what already exists for such training and have reviewed grants that are available from the Dept. of Health and Human Services. They have decided to forego the possibility of obtaining one of these Federally-funded grants and will go to the private sector. The D.A. was supportive of the work that has been done thus far and encouraged by the commitment of the task force.

The Making of the Achiever, Allan Cox, Ballantine Books, 201 E. 50th St., New York 10022, 258 pp. paperback, \$3.95. This self-help book is a guide on how to win distinction in your company, a book geared to specific needs of managers who seek to become high achievers. Cox's exercises force a manager toward self-assessment with an emphasis on individual initiative and responsibility. Allan Cox is a Chicago-based management consultant who uses Adlerian principles in his consulting, teaching and writing.

The Next Step, a parent education program featuring the book, The Effective Parent, was released December 1st by American Guidance Service, Circle Pines, MN 55014 (800/328-2560).

The program, authored by Adlerians Don Dink-meyer, Sr., Don Dinkmeyer, Jr., Gary McKay, Joyce McKay, James Dinkmeyer, will provide a dynamic approach to parent education. The focus will be on strengthening the parent as a person as well as parental skills.

Topics include: Building Self Esteem, Coping with Stress, Discipline. There is an emphasis on the development of a problem solving process, thus the program goes beyond the educational to include direct experiences in problem resolution. This program is accompanied by the Next Step video tape which will cover the basics of Adlerian parent education skills, the problem solving process, and the details of family meetings.
